

## END USER LICENCE AGREEMENT

This is a legal agreement ("Agreement") between Deny All SAS, a French corporation having offices at 63 ter Avenue Edouard Vaillant, 92100 Boulogne-Billancourt, France ("**Deny All**"), and you, the party licensing Software ("**You**"). This Agreement covers Your permitted use of the Software.

BY CLICKING "I AGREE", YOU INDICATE YOUR ACCEPTANCE OF THIS AGREEMENT AND YOU ACKNOWLEDGE THAT YOU HAVE READ ALL OF THE TERMS AND CONDITIONS OF THIS AGREEMENT, UNDERSTAND THEM, AND AGREE TO BE LEGALLY BOUND BY THEM.

If You do not agree with the terms of this Agreement, You may not use the Software, as such term is defined below. The Software can only be provided to You by Deny All. The term "Agreement" includes any exhibits to the document.

### 1. TERMS

The term "Software" means (i) the 2 products named Deny All Auditor and Deny All Vulnerability Manager that You ordered either directly from Deny All or from any partner of Deny All; (ii) the associated user manuals and user documentation, if any, as well as any updates, improvements, additions, enhancements and other modifications or revised versions of the 3 products that may be provided to You by Deny All from time to time that were developed by Deny All; (iii) any graphical user interfaces You obtain from Deny All that were developed by Deny All; (iv) all the documents, including audit reports and other outputs, that may be generated by the 3 products.

Any software that is not marked as copyrighted by Deny All are not Software as defined under this Agreement and are subject to other license terms as described in the documentation.

This Agreement commences on the date on which You agree with this Agreement and continues until it is terminated according to the terms of this Agreement.

### 2. GRANTS

Subject to the terms and conditions, and Your acceptance, of this Agreement, Deny All grants to You a non-exclusive, non-transferable license in the form of a USB key or a virtual machine only to use the Software (i) solely for Your internal operations and internal security purposes to seek and assess information technology vulnerabilities and misconfigurations for Your own networks; and (ii) to provide services to third parties to seek and assess information technology vulnerabilities and misconfigurations on the third parties' network. Any rights in the Software not granted in this Agreement are expressly reserved by Deny All.

### **3. TRADEMARKS**

Deny All and its logo are registered trademarks. Deny All does not grant to You, either expressly or by implication, any license or permission under this Subscription Agreement to use any of the Deny All trademarks.

### **4. INTELLECTUAL PROPERTY**

#### **4.1. OWNERSHIP**

This Agreement does not transfer to You any title to or any ownership right or interest in the Software. You acknowledge that Deny All owns and retains all right, title and interest in and to the Software. All enhancements, modifications and derivative works that Deny All or any Deny All-authorized third party makes to the Software or accompanying documentation, and all intellectual property rights therein, will be the property of Deny All. Your rights with respect to the Software are limited to the right to use the Software pursuant to the terms and conditions in this Agreement.

The Software integrates other software listed in Annex A. By acknowledging this license agreement, You also acknowledge all the license agreements of these software. Therefore, You may not decompile, disassemble, reverse engineer, or otherwise attempt to modify the source code of these software.

#### **4.2. REVERSE ENGINEERING AND OTHER RESTRICTIONS**

You may not directly or indirectly: (i) sell, lease, redistribute or transfer any of the Software on a stand-alone basis; (ii) decompile, disassemble, reverse engineer, or otherwise attempt to derive, obtain or modify the source code of the Software; (iii) reproduce, modify, translate or create derivative works of all or any part of the Software; (iv) rent, lease or loan the Software in any form to any third party; (v) remove, alter or obscure any proprietary notice, labels, or marks on the Software; or (vi) sell, resell, loan or otherwise provide access to third parties to the Deny All software interface provided to You.

You may not sublicense any of the rights granted to You in this Agreement. You may not distribute or otherwise provide Software to third parties unless authorized to do so in writing by Deny All. You are responsible for all use of the Software and for compliance with this Agreement; any breach by You or any user using the Software on Your behalf shall be deemed to have been made by You. You may not copy the documentation as You agree it is provided to You under copyright protection. For the avoidance of doubt, You may not include or redistribute the Software on physical or virtual appliances to perform on-site scans.

#### **4.3. RESTRICTIONS ON THIRD PARTY USE AND ACCESS**

You may permit a third party (a "Third Party") to (a) use the Software to perform security

services for Your business or (b) administer the Software, each provided that: (i) any such Third Party use or administration is for Your sole benefit and on Your behalf; (ii) You acknowledge that You shall be legally responsible for the Third Parties' use of the Software including any obligations arising from such use and any breach by the Third Party of the terms and conditions of the Agreement; (iii) usage by You and the Third Party, when taken together, does not at any time exceed the usage restrictions imposed under this Agreement. Upon sixty (60) days notice, Deny All shall have the right to withdraw its consent to the use of any Third Party in its reasonable discretion. You agree not to deliver or otherwise make available the Software, in whole or in part, to any party other than Deny All, except for purposes specifically related to Your use of the Software, without Deny All's prior written consent. You agree to use Your commercially reasonable efforts and to take all reasonable steps to ensure that no unauthorized parties have or use the Software and that no unauthorized copy, publication, disclosure or distribution of the Software, in whole or in part, in any form is made by You or any third party. You agree to notify Deny All of any unauthorized access to, or use, copying, publication, disclosure or distribution of the Software.

#### **4.4. PASSWORD**

The password required to boot and use the Software may not be transmitted or shared, as the usage of the Software is restricted to You considering Your skills and Your role regarding IT security.

## **5. RESPONSIBILITY**

#### **5.1. UPDATES**

The Software is designed to automatically check for updates at each boot.

During this check, specific information are transmitted to Deny All (serial number, license number and Software version) and stored for statistic purpose. These information may contain nominative information.

Therefore, Deny All performed the mandatory declarations to the CNIL (Commission National Informatique et Libertés).

#### **5.2. TECHNICAL SUPPORT**

Deny All provides a « Support » webpage and a contact form that You may use for technical assistance. Deny All warrants that all the requests for technical assistance coming from this contact form will be answered within 24 hours.

#### **5.3. RESPONSIBILITY**

Deny All warrants that the unmodified Software will, under normal use, substantially perform

the functions described in its technical documentation. If there is a breach of this warranty, then Deny All's sole obligation, and Your exclusive remedy, will be for Deny All, at its option, to correct the performance of the Software at no charge so that it substantially performs the functions described in its technical documentation or to replace the Software. You acknowledge that, because the license for the Software is at no charge, the remedies described in the preceding sentence are sufficient and cannot fail of their essential purpose.

Deny All DOES NOT MAKE ANY WARRANTIES OF ANY KIND, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING ANY WARRANTIES OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, INTEGRATION, PERFORMANCE AND ACCURACY, AND ANY IMPLIED WARRANTIES ARISING FROM STATUTE, COURSE OF DEALING, COURSE OF PERFORMANCE OR USAGE OF TRADE, OTHER THAN THOSE WARRANTIES WHICH ARE IMPLIED BY AND INCAPABLE OF EXCLUSION, RESTRICTION, OR MODIFICATION UNDER APPLICABLE LAW. Deny All MAKES NO WARRANTY THAT THE SOFTWARE WILL OPERATE ERROR-FREE, FREE OF ANY SECURITY DEFECTS OR IN AN UNINTERRUPTED MANNER.

UNDER NO CIRCUMSTANCES WILL Deny All BE LIABLE TO YOU OR ANY OTHER PERSON OR ENTITY FOR DIRECT (INCLUDING FOR NEGLIGENCE, STRICT LIABILITY, BREACH OF CONTRACT, MISREPRESENTATION AND OTHER CONTRACT OR TORT CLAIMS), INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, EXEMPLARY OR PUNITIVE DAMAGES (INCLUDING NEGLIGENCE, STRICT LIABILITY, BREACH OF CONTRACT, MISREPRESENTATION AND OTHER CONTRACT OR TORT CLAIMS; LOST PROFITS; OR ANY DAMAGES RESULTING FROM LOSS OF DATA, SECURITY BREACH, PROPERTY DAMAGE, LOSS OF REVENUE, LOSS OF BUSINESS OR LOST SAVINGS), ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT, THE PERFORMANCE OF THE SOFTWARE OR OF ANY OTHER OBLIGATIONS RELATING TO THIS AGREEMENT, WHETHER OR NOT Deny All HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. YOU ARE SOLELY RESPONSIBLE AND LIABLE FOR VERIFYING THE SECURITY, ACCURACY AND ADEQUACY OF ANY OUTPUT FROM THE SOFTWARE, AND FOR ANY RELIANCE THEREON.

## **6. TERM**

### **6.1. DURATION**

The duration of the license agreement is a period of twelve (12) months from the billing date. At the end of this period, You may renew Your license agreement for another year or proceed to termination as described below.

The duration of the evaluation license is a period of fourteen (14) days from the first boot of the Software. During this period, You may ask Deny All to activate the Software by subscribing the yearly license.

## **6.2. TERMINATION**

This Subscription Agreement and Your license to use the Software shall terminate automatically if You fail to comply with any term or condition of this Subscription Agreement or if the Deny All Software Licence Agreement between You and Deny All terminates.

Immediately upon the expiration or termination of this Subscription Agreement, You shall destroy or return to Deny All the USB key, and shall certify to Deny All in writing that through Your commercially reasonable efforts and to Your knowledge all such materials have been destroyed or returned to Deny All.

## **7. GOVERNING LAW AND DISPUTE RESOLUTION**

This Subscription Agreement shall be governed in all respects by the French laws, without regard to choice-of-law rules or principles.

You and Deny All submit to the exclusive jurisdiction of the commercial courts of Nanterre (92500), France, for any question or dispute arising out of or relating to this Subscription Agreement. Due to the high costs and time involved in commercial litigation before a jury, the parties waive all right to a jury trial with respect to any and all issues in any action or proceeding arising out of or related to this Subscription Agreement.

You expressly agree with Deny All that this Subscription Agreement shall not be governed by the U.N. Convention on Contracts for the International Sale of Goods, the application of which is expressly excluded.
